### **PBP and MULTI-AGENCY UNITS CONDUCT ROUND UP**

**PITTSBURGH** - On Tuesday, November 9<sup>th</sup>, 2010 at 0500am, the PBP along with various multi-agency police units conducted an multi-zone roundup targeting suspects wanted on outstanding warrants. The following are the results of the saturation detail with no injuries reported.
