I. CALL TO ORDER: Chair Rev. Liddy Barlow Called the meeting to Order at 3:33 p.m.

- III. **PUBLIC COMMENT:** Vincent Omar Johnson from the University of Pittsburgh, School of Law was present to observe the meeting. Thea Young was also present to remind Commissioners and staff of the Racial Justice Summit on January 19-20<sup>th</sup>.

### IV. COMMITTEE AND STAFF REPORT

- A. Director's Report
  - 1. Personnel:

- **1.a.** Orientation for our two newest commissioners was held in November. Mayor's office staff were invited however they did not attend.
- **1.b.** Final approval for our next general solicitor was obtained in November, and an award notice was sent to the firm. Courtney is working with Law to get the contract started however we cannot do a resolution to encumber the funding until January.
- **1.c.** Rita Porterfield, the Commission's most senior investigator, has accepted the role of Acting Deputy Director until the role has been filled. The job will be posted for four weeks, followed by telephone and in-person interviews. We anticipate a permanent placement around late January/early February based on past hiring timelines.
- **1.d.** Our budget hearing is scheduled for December 6, 2023 at 1:30pm. All are encouraged to participate in person if they are able. Again, we are trying to show Council that we are operating with a small staff and could use an extra set of hands to better support them in reaching their constituents.

### 2. Investigation:

- **2.a.** As of 11/27/2023 there are 70 open cases, 16 pending intakes, one open testing case, and nine post-cause cases pending mandatory conciliation/public hearing.
- **2.b.** We anticipate closing 11 cases at Compliance Review this month, in addition to the 9 cases from November that we were unable to close due to lack of quorum.
- **2.c.** On December 1, 2023 I am participating in a briefing with Councilperson Gross regarding the Residential Wholesale Homebuying legislation to review the changes for our part of City Code. On that day I am also participating in a review of zoning code with a number of city departments and community stakeholders, specifically to look at temporary housing options for the unhoused.

### 3. Outreach

- **3.a.** A landlord training will be conducted on January 31st in collaboration with the Fair Housing Partnership. This can be shared with any landlord who may be interested in fair housing information and is free. Registration link here: <a href="https://fairhousingpittsburgh.rsvpify.com">https://fairhousingpittsburgh.rsvpify.com</a>
- **3.b.** We are up to 6 volunteer mediators that we work with to resolve cases, in addition to our five trained staff members. This proves especially useful in cases where a conflict of interest occurs.
- **3.c.** Community Development granted our request for \$60,000 for a three-year contract with Just Mediation Pittsburgh. These funds will be available in 2024 and the contract process will begin then. JMP will distribute information to landlords and tenants on fair housing rights and responsibilities in exchange for our financial support of their mediators.

- **3.d.** We are beginning Fair Housing Month planning for 2024. The topics we are looking at are criminal history as it is user in rental criteria, our enhanced domestic violence protections, discrimination in the appraisal process, language access in housing, and predatory wholesale homebuying.
- **3.e.** We have begun sending packets of our resources to various locations across Pittsburgh. We are continually building our list of folks to reach out to, so please make suggestions as you think of them. This month we sent information to local college groups, Latino community groups, Jewish Family and Community Services, Neighborhood Legal Services, First Muslim Mosque, and the Islamic Community Center. We are also sending packets to you all for sharing with your networks.
- **3.f.** A Know Your Rights training is scheduled with Jewish Family and Community Services on January 18, 2024 to educate their career services and refugee services staff on civil rights protections and resources. A similar training is to be scheduled with RentHelpPGH as well.

# PERSONNEL AND ADMINISTRATION

- We received 16 applications for Deputy Director, which were redacted and are being reviewed to choose telephone interview candidates. Many applicants do not seem to understand the residency requirement so staff intends to make it very clear before there is even a telephone interview scheduled.
- We need to schedule a Community Relations Committee meeting very soon. We have a number of projects and legal developments that commissioners should have a greater hand in coordinating.

# CASES AND ENFORCEMENT

- As of 1/5/2024 there are:
  - o 62 open cases
  - o 10 pending intakes
  - o 8 post-cause cases pending mandatory conciliation
  - o 6 pending court cases.
- Compliance Review will see 11 determinations this month, including one successful conciliation. We are on track to meet our case closure goals after the first quarter of the case processing year thank you, investigators!

# EDUCATION AND OUTREACH

- We are continuing planning for Fair Housing Month 2024 and welcome Commissioner participation. We meet at noon every other Monday via Teams.
- We are continuing to send packets of our resources to various locations across Pittsburgh to improve our outreach. This month we sent information to service providers who see survivors of domestic violence to update them on the City Code enhancements. Some commissioners should have also seen resources come via mail. We are continually building our list of places to reach out to, so please make suggestions as you think of them.
