Re: Zoning Map Amendment DCP-MPZC-2025-00129, Council Bill 2024-1417

An application was submitted for a Zoning Map Amendment to rezone parcels 45-A-166 and 45-E-43 in the Marshall Shadeland neighborhood from R1D-H (Single Unit Detached Residential, High Density) to UC-MU (Urban Center Mixed Use). This submission is presently being considered by the Pittsburgh Planning Commission, which will be taking action at an upcoming public hearing. The action that Planning Commission will make will be a recommendation to City Council.
