This budget line was necessary at the time to ensure that the City of Pittsburgh could pass a balanced budget and five year plan. (Final Rule, p. 184)
Brief description of recipient's approach to ensuring that response is reasonable and proportional to a public health or negative economic impact of Covid-19	The anticipated workforce reduction budget line was calculated by taking 10.25% of 2021 salary lines across all City departments (15% for the Office of the Mayor). The total was increased by 6.5% from 2022 through 2024 to account for inflation, scheduled increases to base wages (per collective bargaining), and increases in benefit costs. This resulted in the \$113 million reduction that the City needed to balance the budget based on revenue forecasts from the Department of Finance.
