

NOTICE OF FINDING OF NO SIGNIFICANT IMPACT AND NOTICE OF INTENT TO REQUEST RELEASE OF FUNDS

This notice shall satisfy two separate but related procedural requirements for activities to be undertaken by the City of Pittsburgh.

REQUEST FOR RELEASE OF FUNDS (1) – PBV Project

On or about Monday May 25, 2026, the City of Pittsburgh will submit a request to the U.S. Department of Housing and Urban Development (HUD) to release Federal funds under Title 1 of the Housing and Community Development Act of 1974 as amended for the real estate project described below.

Cliffside Overlook (the “Project”), located at 1717 Cliff Street Pittsburgh, PA 15219, is a residential development which consists of new construction of four (4) units; all four units are three bedrooms, 1 ½ bathrooms in the Hill District neighborhood of Pittsburgh. Target tenants are individuals with disabilities, families who have experienced homelessness, trauma, and domestic violence. The units are in Pittsburgh’s Hill District neighborhood. The Cliffside Overlook will provide quality affordable housing for Hill District residents who are most in need. The location of this project is within walking distance of numerous employment organizations, social service agencies, medical facilities including hospitals, downtown Pittsburgh, and public transportation. The Housing Authority City of Pittsburgh (“HACP”) has committed Project Based Vouchers (PBV) subsidies to the 4 units.

Funding for the Project will consist of the following approximate amounts; a Deferred Developer Fee of \$96,846; a PHFA PHARE grant of \$150,000; a private bank loan of \$595,000; a private bank grant of \$600,000; a private grant of \$250,000; the URA’s Rental Gap Program of \$225,000 will be sourced through a loan of \$225,000. The HACP has committed four (4) Section 8 Project Base Vouchers. The total estimated cost of the development is \$1,916,846.

FINDING OF NO SIGNIFICANT IMPACT (2) – PBV Project

The City of Pittsburgh has determined that the project will have no significant impact on the human environment. Therefore, an Environmental Impact Statement under the National Environmental Policy Act of 1969 (NEPA) is not required. Additional project information is contained in the Environmental Review Record (ERR). The ERR will be made available to the public for review either electronically or by U.S. mail. All comments received by Wednesday, May 20, 2026 will be considered by the City of Pittsburgh prior to authorizing submission of a request for release of funds. Comments should specify which Notice (Request for Release of Funds 1 or Finding of No Significant Impact 2) they are addressing.

ENVIRONMENTAL CERTIFICATION

The City of Pittsburgh certifies to HUD that Corey O'Connor in his capacity as Mayor, City of Pittsburgh, consents to accept the jurisdiction of the Federal Courts if an action is brought to enforce responsibilities in relation to the environmental review process and that these responsibilities have been satisfied. HUD's approval of the certification satisfies its responsibilities under NEPA and related laws and authorities and allows the Housing Authority of the City of Pittsburgh to use development funds.

OBJECTIONS TO RELEASE OF FUNDS

HUD will accept objections to its release of funds and the City of Pittsburgh certification for a period of fifteen (15) days following the anticipated submission date or its actual receipt of the request (whichever is later) only if they are on one of the following bases: (a) the certification was not executed by the Certifying Officer of the City of Pittsburgh; (b) the City of Pittsburgh has omitted a step or failed to make a decision or finding required by HUD regulations at 24 CFR part 58; (c) the grant recipient or other participants in the development process have committed funds, incurred costs or undertaken activities not authorized by 24 CFR Part 58 before approval of a release of funds by HUD; or (d) another Federal agency acting pursuant to 40 CFR Part 1504 has submitted a written finding that the project is unsatisfactory from the standpoint of environmental quality. Objections must be prepared and submitted in writing in accordance with the required procedures (24 CFR Part 58, Sec. 58.76) and shall be addressed to the HUD Field Office of Public Housing in Pittsburgh at PittsburghPIH.ER@hud.gov regarding Project Based Vouchers.

Potential objectors should contact the HUD Field Office of Public Housing in Pittsburgh via email to verify the actual last day of the objection period.
