1. Homewood Park Public Art

Applicant: City of Pittsburgh Department of City Planning

Representatives: Camerin Nesbit, Juliandra Jones, Mikael Owunna, Najja Moon (Artists); Tony Cavalline (DCP), Kevin Kunak (DCP),

Artists Camerin Nesbit, Juliandra Jones, Mikael Owunna, and Najja Moon introduce their proposed projects.

McDill thanks the artists for the diversity of style and thought in their proposed pieces. She asks about the maintenance of the projects over time. Jones and Owunna speak to the materials maintenance of their projects.

Bethea compliments the mix of mediums for this project.

Hornstein thanks the artists and asks Moon about her community engagement. Moon describes her interactions with community youth and the planned engagement that will help shape the project forms. Hornstein asks if there are any other plans beyond that engagement. Moon says that is what is planned so that the work reflects the people using the space.

Public comment:

Ayodeji Young of Homewood Community Sports speaks in support of the proposed projects by Nesbit, Jones, and Moon, and against the project by Owunna at the proposed location.

Dominique Swift of Homewood Children's Village speaks in support of Owunna's proposed project.

A speaker identifying as Swamp Monster speaks against Owunna's proposed project.

John McDonald of King's Kids Foundation speaks against Owunna's proposed project.

Chad Parker of Homewood Community Sports speaks in support of the art but against the project by Owunna at the proposed location.

Michelle Stewart speaks against the proposed project by Owunna.

Marques speaks in support of the proposed project by Owunna.

Derrick Tillman speaks against the project by Owunna at the proposed location.

Ajani Powell of the Greater Pittsburgh Arts Council speaks regarding the proposed project overall.

Mubarik Ismaeli of Homewood Community Sports speaks in support of the art but against the project by Owunna at the proposed location.

Bethea states that the community clearly has high regard for Owunna's work but that there is pushback for this location. She asks Owunna about the process. Owunna speaks about his engagement with the community, the local support that was received for this project, the goals of the project, and its location.

Martinez asks Owunna about the in-person meeting. Owunna describes an earlier draft of the project design and the feedback received from it that led to the current proposal. He speaks about the Development Activities Meeting, which addressed comments on the placement of the artwork.

McDill thanks the community for their input and notes the importance of this conversation.

Bethea notes the earlier redesign that Owunna spoke of, and states uncertainty that another redesign would lead to a better outcome. She asks the other Commissioners for thoughts on how to move forward. McDill says they should not ask Mikael to move away from what he would naturally design, but that they also cannot disregard the feedback from the community.

Kunak says that the project was brought to the Commission as one application, although it involves components by four artists.

The Commission and staff discuss what is possible in potential motions.

Martinez asks if contracts had already been brokered for installation. Cavalline says that what has been done is necessary outreach and planning with contractors, not finalized plans.

McDill asks about the construction timeline of the project. Hornstein speaks about the project timeline and the artists coordinating their work with DPW's construction.

Carver asks about the fencing shown in the site plan. Lennon clarifies that is a guard rail.

Winston asks if the site has an emergency generator. Mastroberardino says yes. He asks where that is located on the plan. Lennon indicates where it is shown.

Carver asks about the proposed plantings. Lennon says he does not have ready access to that information but can provide it if needed.

Zeigler comments that there are no construction drawings provided. Mastroberardino says that they do not publicly share plans of public safety buildings.
